Current sources of investment ideas



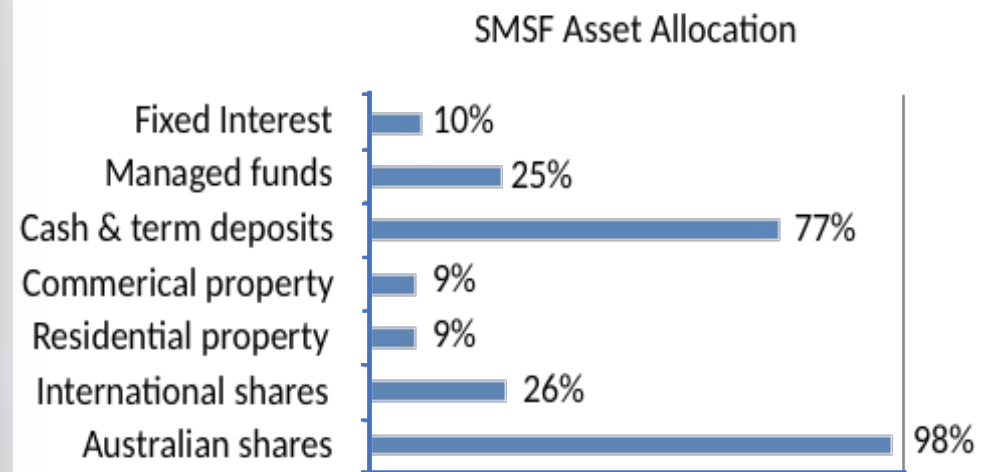
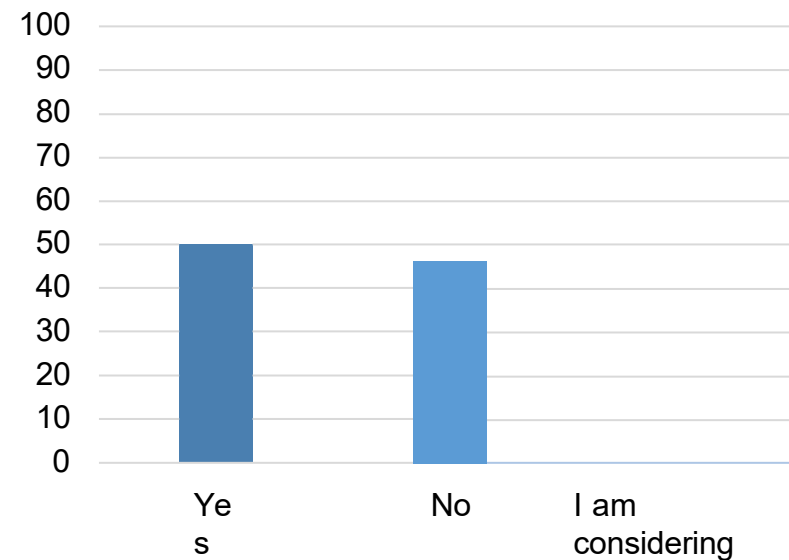
Can you estimate what percentage of your portfolio is made up of small & micro-cap stocks?

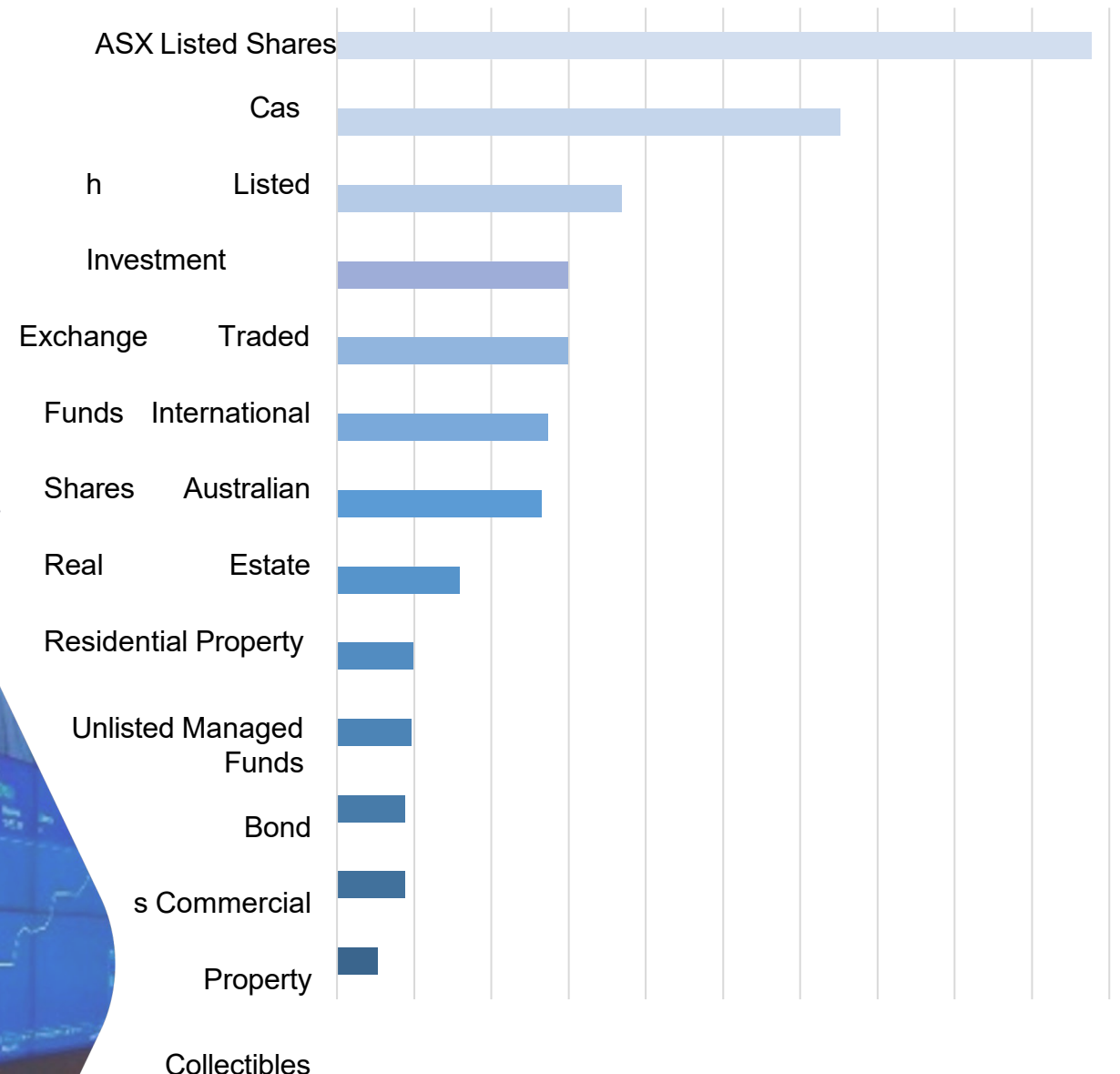

Which of the following do you currently hold in your portfolio?



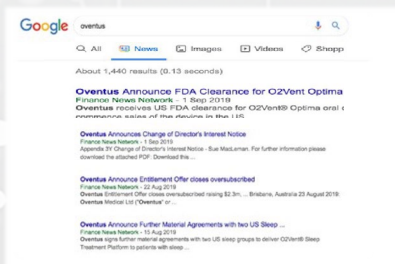

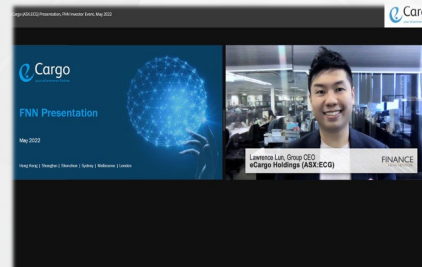

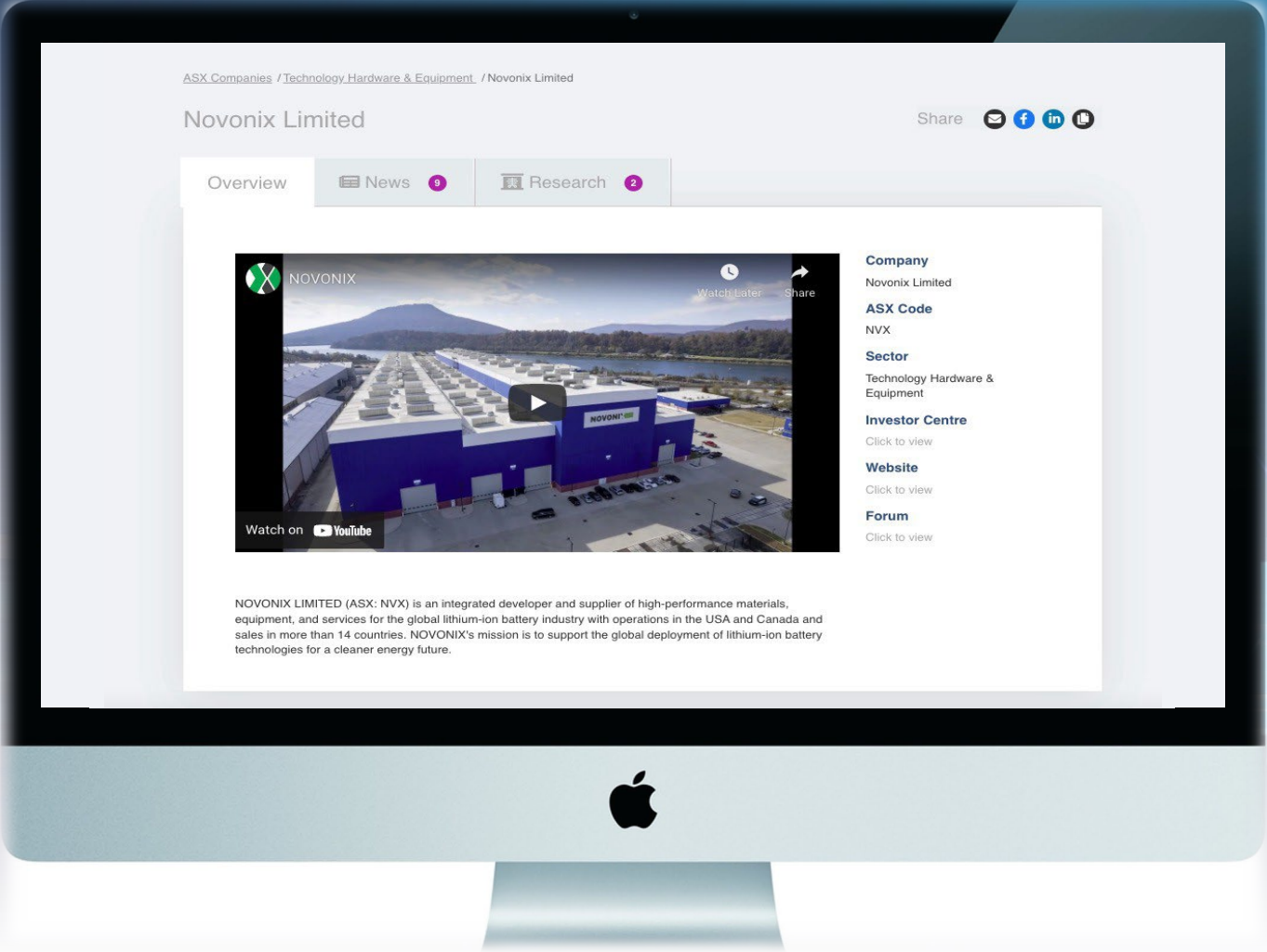
